The Tender applicant shall deposit earnest amount as mentioned above through RTGS/NEFT in the account of Sangli Urban Co-op. Bank Ltd; Sangli (A/c No.00070380003940 [IFSC Code HDFC 0000007]) with the tender application on before Tender Sale Date. The said amount is refundable without interest. 5.) 25% amount shall be deposited through RTGS/NEFT in the account of Sangli Urban Co-op.
